 KOM OFFERS AN ARRAY OF SERVICES TO HELP REFUGEES ACCESS RESOURCES AND EDUCATION THAT IMPROVE THEIR QUALITY OF LIFE. IN 2024, KOM PROVIDED CASE MANAGEMENT FOR OVER 675 ADULTS TO ADDRESS NEEDS INCLUDING: PUBLIC ASSISTANCE ACCESS, MNSURE NAVIGATION, HOUSING SUPPORT, IMMIGRATION SERVICES, AND SERVICES TO ELDERLY. KOM'S YOUTH CASE MANAGER PROVIDED WRAPAROUND SERVICES FOR 76 KAREN YOUTH WITH SUBSTANCE USE AND/OR MENTAL HEALTH ISSUES.
